

EMHA ORDER WITH NOTICE

The following are orders with notice that shall be strictly followed without deviation. Such order with notice is hereby set out for incorporation to be made a part of, as if wholly re-written therein as an integral requirement of compliance and made a part of any court order in which it is referenced to comply with the court's Electronic Monitoring Home Arrest (EMHA) Program.

WARNING

Failure to comply will result in revocation of bond, probation holder, or any other type of arrest with further result of immediate incarceration.

Type 1 EMHA

The person wearing the court ordered EMHA device shall be designated at the "subject wearer." The subject wearer shall be on Home Confinement, which means confine himself or herself to a residence or location only at an address designated by the court or the court's department of probation, community control, or pretrial services, ("department") which is located in the lower level of the municipal court building, lower level, located at 295 Broadway Street Jackson, Ohio, (use lower Broadway Street entrance), telephone contact number 740.288.2175.

The subject wearer shall not leave the address or location designated by the court or department until and unless the court or department authorizes the subject wearer to otherwise authorizes the subject wearer to be at another location under specific terms of travel and condition between the residence and the designated other location.

If the subject wearer is found to be or is determined to be or have been in violation of terms, then the subject wearer shall be subject to an immediate arrest and incarceration based upon the report of the victim, EMHA monitoring agency, the department, or any court or law enforcement officer.

Type 2 EMHA

The person wearing the court ordered EMHA device shall be designated at the "subject wearer." The subject wearer shall be on Home Confinement, which means confine himself or herself to a residence or location only at an address designated by the court or the court's department of probation, community control, or pretrial services, ("department") which is located in the lower level of the municipal court building, lower level, located at 295 Broadway Street Jackson, Ohio, (use lower Broadway Street entrance), telephone contact number 740.288.2175.

The subject wearer shall be authorized to travel to and from his or her place of employment only by taking the most direct route of travel between the home and place of employment during the minimum time necessary to travel between the home and the place of employment.

If the subject wearer is found to be or is determined to be or have been in violation of terms, then the subject wearer shall be subject to an immediate arrest and incarceration based upon the report of the victim, EMHA monitoring agency, the department, or any court or law enforcement officer.

Type 3

The person wearing the court ordered EMHA device shall be designated at the "subject wearer."

The subject wearer shall be on Restrictive Release, which means restrict himself or herself to a geographical area designated by the court or the court's department of probation, community control, or pretrial services, ("department") which is located in the lower level of the municipal court building, lower level, located at 295 Broadway Street Jackson, Ohio, (use lower Broadway Street entrance), telephone contact number 740.288.2175.

The subject wearer shall be restricted in travel to a geographical zone defined by the court set out in the terms of a court order. The court may express the description of the permissible zone where the subject wearer is permitted to be in terms of an Inclusion Zone or in terms of an Exclusion Zone or both and inclusion and exclusion zone. An exclusion zone is a geographical area or zone described such that the subject wearer is not permitted to be within the borders thereof.

If the subject wearer is found to be or is determined to be or have been within the borders of an exclusion zone, then the subject wearer shall be subject to an immediate arrest and incarceration based upon the report of the victim, EMHA monitoring agency, the department, or any court or law enforcement officer.

The above order shall be designated as General Order for the General Journal numbered 2023-09-08 A, and referenced also as a Court Reference Number Operations Manual 2023-1.

The above is adopted as a court order and to be journalized accordingly.
